VI. US Army Corps Of Engineers Barrier Ring Follow Up Discussion On Sand Sourcing (Kelly Brooks, 30 Minutes)

Kelly Brooks provided sand sourcing options and information from her research as the CEPRA Project Manager in the Coastal Resources Division at the Texas General Land Office.

At the December 2020 meeting Dr. Bill Merrell of Texas A&M University at Galveston gave a presentation on the topic of the USACE Barrier Ring Protection System. This presentation led to questions about the availability of sand to construct and maintain a dune system like this.

- Babe's Beach Galveston Beneficial Use of Dredge Material (BUDM)
- Dellanera Beach/Dune Harvey FEMA Repair
- Historic Stretch

These projects are made possible mostly in part due to our relationship with the Texas General Land Office Coastal Erosion Planning and Response Act team who assist with project management and funding and the City of Galveston Industrial Development Corporation with funding assistance.
